"I sent the bulk of the water on down the river last week. It has been averaging about 65 cfs I'm now only taking about 25 cfs down the combined canal. Of that 25 I'm still sending 20 to pelican 3 to Brough and gaining very slowly on Cott. As the weather warms up I will shut off the flow to Pelican and allow Cott to finish filling. Making frequent adjustments right now in this cold weather is very difficult with the ice at the river heading so I'm intentionally keeping Cott. a little from full because there is no way to shut off the canal entirely in an emergency. I'm just keeping enough flowing to Brough to keep the pipeline from freezing until it warms up. It will be overflowing on down to Pelican. Pelican is just now full but there is still a week or two at the current flow that we can overfill before any problems and hopefully by then it will be warm enough to shut down and do the pipeline repair. Like I already said I did pinch that back and try to calculate how much to leave running into pelican based on where we want it on the 1 of march. If it remains really cold a lot longer than III just have to shut the river heading down tighter and pinch back the flow to pelican more."

Alan Cooper presented 3 shares to convert to M & I water. His application was missing the map so Shane moved to approve application pending Alan getting the map to David.

Class B Assessments were not billed correctly, they were assessed at the Class A rate. A Letter will be sent to all Class B shareholders letting them know of the difference.

The annual meeting is coming up on the last Saturday of February. The time is set at 1:00 with polling to begin at 12:00. Agenda for the meeting was set including inviting the fish and game to report on the fish screen and settling pond.

Shane followed up on the question from last month regarding the bird refuge water filing change. The filing is for irrigation so they changed the application to use the water for what they are actually using it for.

The conservancy district has a plan in place to address a leak at Vern's. When the weather breaks then the valve needs to be put in the poor farm pipe.

"Water is in the Panama pipeline from Brough is now ready to go. I am currently filling the Pelican line again after working with Dave and Fernando on identifying the leak and repairing leaky air vents. There is a small leak still on the flange where it is cracked next to the connection on the valve for the Bird Refuge leg. Fernando thinks he can fix it with an epoxy coating but after the initial filling of the pipeline we opened drains but could not get all the water out. After several days of trying to drain the pipeline we tried pumping it out for over 24 hrs without sucess. Finally in effort to get water running we decided to just allow it to continue leaking until fall. It is a very small slow leak. The pipeline should be all pressured up by morning. We are at least a weeks away from finishing repairs on the 2- 48inch leaks and getting that section of pipeline back up and running. I believe Jim is planning on helping me fuse the upper one together on Monday. The lower one in Vern's property is back together now but not backfilled yet. Steve will help us get that done tomorrow. We cant pressure check everything until we get the upper one done as well. After that is all done I will be able to put water into the lower Cott. line. There will need to be some work done on the south side of Pelican with the dike structure throughout the summer to keep water running to the screens."

Gardner pond is also full and I assume with a snow pack above 100% that the high lake will be full as well. Showtell shows the that snow pack is about 112% right now. Shane is assuming Moffat is going to want to pull 600 acre feet because they know they can replace it.

Shane moved to allocate 1.25 an acre foot as suggested by Devin. Steve seconded.

Trina Hendrick from DWR would like to start pumping water out of Bullock late July to early August so that the head gate can be repaired. It will take about 20 days to drain the water low enough to repair the head gate. Once the head gate is repaired the screen will be replaced as well. There was some discussion as to whether the water should be ran down the canal to Pelican or pumped into Cottonwood. It was ultimately decided to ask William Merkley the cost to pump the water before a decision is made. Trina also mentioned the DWR is planning to spray the foliage in Bullock with Renovate which has a three week residual effect. She wanted to ensure the spray wouldn't affect any hay crops. Decision was to pump or turn water into the canal three weeks after it has been sprayed. Once it is in either Pelican or Cottonwood it will be diluted enough that it won't affect crops.

Any certificates that need to be reissued because they have been lost by the lien holder require both the shareholder and the lienholder to sign an affidavit stating that they have been lost.

Pelican lake screens have been cleaned. Dirt is being moved to direct water better. There are a few issues on the canal that need to be fixed. With the NRCS funding, Jimmy Slaugh will begin work on the canal bank stabilization project now that the water is emptied. Steve will get in contact will him and see if his is available, if not they will find someone else. Gene Brown's ponds are seeping into the OPIC canal, Dave will contact Gene as soon as they are finished repairing Pelican lake and see what needs to be done to repair it. Greek cut needs repaired as well.

Ouray Park Irrigation Company recently purchased a trailer to store inventory and records belonging to the OPIC. The trailer was purchased for \$1700 and is currently at Four Star. Mitch moved that it be kept at Four Star so that it can be less likely to be broken into or damaged. Steve seconded. Motion passed.

Uintah Water Conservancy District currently has 2,400 shares of Green River water that they are paying for but not using. Shane wondered if anyone would be interested in purchasing it. Board discussed that there would be limits on how it could be used, how it would be made available, and that the conservancy district would need to insure that it could be delivered. Shane will find out more information before a decision is made.

Steve moves to hire Amber Allred as the new Ouray Park Irrigation Company Corporate secretary. Paul seconds, motion passes unanimously. Devin has been pumping water some of last week and all of this week from Bollock to Cottonwood. It is a lot of work to keep it going but he feels it has been going pretty well. However, they have not been able to run it around the clock due to the risk of damaging the pump running it if it trashed off or lost prime in the night. So far, they guess that they have moved about 120 acft. or 18" elevation drop. They feel we will be able to continue running it through the week but will then have to send the rest to Pelican down the canal. The lake is so flat it is just impossible to get the pump out to the deeper water without a major and costly project.

There is a pipeline leak on Four Star and Todd Butler's property. They created a berm and redirected water from Blain's place. It will need to be fixed in the fall.

An updated right of way for the old Mary Nelson pump site was drawn up for Steve Hanberg's pump site on Pelican Lake. Shane moved to approve. Paul seconded. Motioned passed unanimously. The document was notarized by Jake Woodland.

The Board requested that Amber write a memorandum that could be reviewed and discussed at the next scheduled board meeting.

The upper lake inspections were scheduled for Sept. 10th, but were requested to be moved to the 9th. Plan to meet at Paradise and ride ATV's for the inspection. Dave agreed to attend.

Steve moved to approve payables. Mitch seconded. Motion carried.

Shane reported that he hired Quinton Murray to spray weeds and trees. He able to spray trees up to the rope arena before it got too cold.

Board discussed state approval for M&I shares. It has historically taken several months for the state to approve M&I shares. Dave will need his M&I share transfer ratified by the board soon. Mitch moved to approve his M&I application now. Shane seconded. Motion passed.

Board discussed the proposed budget and water assessments for 2021. There was no oil lease money included in the budget. Shane budgeted \$2,000 to purchase a trailer to haul the OPIC side-by-side. Board determined that the water assessments for 2021 would be M&I \$50/share, OPIC \$30/share. Shane moved to approve. Steve seconded. Motion passed. After much discussion, it was determined that GR would be \$42.92/share plus \$19.39 pumping costs. Shane moved to approve. Mitch seconded. Motion passed.

Steve was recently contacted by Natalie from DWR. They would like to place domelike structures along the shoreline of Pelican Lake. These structures would help eliminate waves and would be better for the fish. The board agreed they didn't have any concerns should the DWR decide to install them.

Scott lorg owns several acres around the Bullock and Cottonwood area, south of LaPoint. He is currently grazing his cows in that area, and requested permission to lease approximately 285 acres of OPIC land for grazing. Assuming he gets funding from GIP, he proposed building a fence that will help keep his cattle off the nearby road. The fence would not be a perimeter fence, but would cross through part of OPIC land. Board requested that Amber work with Scott to write a lease agreement for approval at the next OPIC board meeting. Mitch moved to approve proposed fence line project so that Scott could move forward with the GIP approval process. Shane seconded. Motion passed.

Andrew Dutson from the Utah Division of Water Rights joined the meeting via conference call.

Jake Woodland followed up on his previous request that OPIC contact the BoR. Shane reported that he did speak with Brittney, and it shouldn't be a problem for Finley to use one of the 3 acre pieces owned by OPIC. Jake expressed concern using one of the other sites because of pumping difficulties due to the shallowness of the lake in those areas. Finley would prefer to use the old Jorgensen inlet and utilize the existing culvert that goes under the road. Because Finley owns the land east of Pelican, they would build a pump site there. Shane will contact the BoR and find out the feasibility of using the existing inlet, which would hopefully alleviate the need to switch land used for wetlands. Assuming that OPIC and the BoR allow Finley to use the existing culvert; a decision will need to be made on a lease agreement and value. The board will find out more information before they make a decision.

Steve voiced concerns allowing Finley to use water from Pelican instead of Cottonwood. Historically, OPIC has only allowed shareholders to use water from their designated reservoir. A decision needs to be made by the board so the rule is the same for all shareholders. If OPIC does allow Finley to use water from Pelican in the off season, how will the board determine the allocation? It is difficult to know how the next water year will be without knowing snowfall and reservoir levels. Due to this uncertainty, if OPIC did allow an allocation, it would need to be a minimal amount so it wouldn't negatively affect other shareholders. He also expressed concern of the possibility of contamination into Pelican Lake due to backflow from Finley. Jake assured the board that measures could be put into place to prevent backflow. Regardless, the board agreed that the bylaws of OPIC may need to be updated to address the unique needs of M&I or Class B water shareholders, without negatively affecting Class A or Class G shareholders. These issues will be addressed in the coming months so that if a revised set of bylaws is needed, it can be presented at the next annual shareholders meeting for approval.

Shane moved to adjourn. Steve seconded. Motion passed.

In Article 28 of the bylaws it states, "No stockholder shall be allowed to transfer the delivery of water represented by his or her shares of stock from one storage reservoir to another without the approval of two-thirds of those stockholders affected by the move." Thus, Finley will need a 2/3 vote from the shareholders at the annual shareholders meeting in order to pull water from Pelican Lake in the future. Until the annual shareholders meeting, the board will honor the Memorandum between OPIC and Finley.

Shane motioned that the discussion move into executive session. Paul seconded. Motion passed.

Shane motioned to end the executive session. Steve seconded. Motion passed.

Shane moved to adjourn. Paul seconded. Motion passed.

Minutes of the Ouray Park Irrigation Company Board of Directors Meeting held October 6th, 2020 at the Avalon Community Center. Board Members present, Dave Yeaman, Mitch Hacking, Shane Frost, Paul Smart and Steve Hanberg. Others in attendance: Amber Allred, Steve Richens, and Jake Woodland.

Meeting called to order at 7:02 PM.

Steve Richens reported on the work he has done for OPIC during 2020. His report was as follows: Dug up 40" saddle, fixed Gusher flange leak, fixed Gene Brown's pipe, fixed leak above Grace's, built up canal bank, cleaned the canal, cleaned head gate at Gene Brown's, cleaned up Greek cut, cleaned fish and game screen, fixed leak in Gene Brown's canal, cleaned up fallen trees, cleaned up Bullock, etc. The board thanked Steve for all of his hard work.

The track hoe will also need repaired soon. The undercarriage needs replaced and some leaks sealed. Steve agreed to help repair the track hoe, rather than ship it to a repair shop. The track hoe is still functional, so it will be repaired once the parts have been ordered and all other scheduled work has been completed.

Jake reported his findings from the BOR. The "West Side Combined Canal Salinity Control Habitat Replacement Plan" prevents Finley from pumping from their land on the northeast corner of Pelican Lake because it is part of the habitat replacement plan. There are however, three, 3-acre pieces that have been excluded from the replacement plan which are owned by OPIC. Jake requested that Finley be allowed to build a pump site on one of these three parcels, or that OPIC make a request from the BOR that one of these parcels be exchanged for an area on Finley's land- which would allow them to build a pump site. Finley would pay for any costs associated with either of these suggested solutions.

After much discussion, the board requested that Shane contact the BoR for more information about trading parcels of land for habitat replacement. The board decided to table any decisions about Jake's proposed solutions until they could get more information. The board also adopted a memorandum by resolution, which would allow Finley to temporarily pump water from Pelican Lake from Nov 1st to March 31st. The board will present this memorandum to the OPIC shareholders at the next annual meeting for discussion and possible approval.

September 2nd, 2020 Minutes were read. Steve moved to approve with some adjustments. Shane seconded. Motion carried.

Payables were as follows: Amber Allred – 450.27 IRS – 156.45 Four Star Ranch, Inc. – 4,996.00

Aycock Miles & Associates – 440.0 Richens Farm – 1,750.00 Moon Lake Electric- 53.08

Shane moved to approve payables. Steve seconded. Motion carried.

Shane reported that the repair for the river heading gate has been installed and is working well. The gate will be taken off in the winter and put back on in the spring to avoid ice damage.

The board has received the dam inspection reports for Cliff and Whiterocks, but will discuss them at the next scheduled meeting.

Dam inspections for Cottonwood and Brough are scheduled for October 23rd at 10 am. Paul agreed to attend the inspections.

Jim Slaugh has been working on the canal- four crossings and three drop structures. Once the board has received the bill from Jim, they will submit it to the NRCS for funding.

Bifurcation project has been cancelled because the Tribe did not agree to the terms.

The board discussed the agreement with the River Commissioner that 10% of the water loss is due to evaporation. The board discussed how this agreement was made and where the original agreement could be found. The board requested that Dave contact the Tribe to see if they would be interested in purchasing Cliff and Whiterocks lakes.

Steve submitted his application for 10 shares for M&I usage. Shane moved to approve. Paul seconded. Motion passed.

Scott lorg has requested to lease OPIC land if he agrees to build a fence. The board requested more information- a map showing the proposed fenced area and documents explaining the proposed lease agreement.

The board will set the water assessments for the upcoming year at the November board meeting.
